5a Improving Toronto's Bike Share Program

Origin

(May 5, 2021) Report from the President, Toronto Parking Authority

Summary

In 2020, Bike Share Toronto was focussed on delivering its biggest one (1) year system expansion since the bike share program began. The network of stations grew from 465 stations to 625 stations, including the addition of 1,850 bikes to the system, of which, 300 were pedal assist e-bikes to the system.

This report provides an update to Toronto Parking Authority Board of Directors on the Bike Share program, including a review of 2020 accomplishments, the status of improvements to the Bike Share program that City Council requested in October of 2020, investments in the Bike Share team, development of a Three (3) Year Growth Plan, funding opportunities for the next

expansion of Bike Share, a planned review of Bike Share's rates and rate structure, and a feasibility assessment of integrating PRESTO technology into Bike Share Operations. In addition, this report outlines a proposal to implement a new one (1) year pilot program that will introduce a 45-minute Annual Membership.
