### PROPOSAL

The City of Toronto proposes to amend the Zoning By-law to add a Holding Provision to limit any new development until such time as an acceptable sanitary system solution is implemented to the satisfaction of the Executive Director Engineering and Construction Services and Chief Engineer, at 625-627 Sheppard Avenue East and 6, 8, 10, 12 Greenbriar Road, 1001 Sheppard Avenue East, 1200, 1210 and 1220 Sheppard Avenue East, 35 McMahon Drive and 40 Esther Shiner Boulevard.

The land at 1200, 1210 and 1220 Sheppard Avenue East is also subject to an application under the Planning Act for approval of plan of subdivision, Application No. 19 208996 NNY 17 SB.

**If you wish to be notified** of the decision of the City of Toronto on the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk, Attention: Administrator, North York Community Council, at the address or e-mail set out in this notice.

**Zoning By-law Amendments Appeal:** If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, Attention: Administrator, North York Community Council, at the address or e-mail set out in this notice.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s).
