City of Toronto Act, 2006 Public Notice

Notice of Proposal to Amend the City of Toronto Municipal Code: Chapter 694, Signs, General (the "Sign By-law")

Notice is given that the Chief Building Official and Executive Director, Toronto Building, is reporting on a proposed amendment to Municipal Code Chapter 694, Signs, General (the "Sign By-law"), to allow for, and regulate, the display of one third party electronic ground sign at the premises municipally known as 2 Strachan Avenue.

The proposed amendment seeks to:

- 1. Modify the existing area-specific amendment to the Sign By-law for the premises municipally known as 2 Strachan Avenue to change the applicable Sign By-law regulations to allow specific portions of the premises to contain the following signs:
 - Two third party electronic ground signs, each containing four sign faces in a back-to-back configuration; two sign faces will display electronic static sign copy measuring 6.1 metres horizontally by 6.1 metres vertically, with a total sign face area of 37.21 square metres each; and, two sign faces displaying static sign copy measuring 6.1 metres horizontally and 0.46 metres vertically, with a total sign face area of 2.8 square metres each; located along the southerly and westerly property frontages; and, a height (highest point of the sign measured from grade) of 10.92 metres; and,
 - First party signs, in accordance with Section 694-24(H) of the Sign Bylaw.

The Chief Building Official and Executive Director, Toronto Building, is recommending that the Council of the City of Toronto refuse the area-specific amendment to the Sign By-law, for 2 Strachan Avenue.

The Planning and Housing Committee may recommend that the Council of the City of Toronto amend the Sign By-law to amend Schedule B, Signage Master Plans and Area Specific Amendments, to modify the existing area specific amendment to Schedule B, Signage Master Plans and Area Specific Amendments, to allow the specific premises to contain, two third party electronic ground signs and first party signs, in accordance with Section 694-24(H) of the Sign By-law.

At its meeting to be held via video conference on Thursday, May 20, 2021 at 9:30 a.m., or as soon as possible thereafter, the Planning and Housing Committee of Toronto City Council will hear from any person or by his or her counsel, agent, or solicitor, who wishes to speak to the matter
