Dear Council Colleagues,

I am writing to seek your support in approving PH 23.17 - Area-Specific Amendment to the Sign By-law for Exhibition Place at this Thursdays Planning and Housing Committee Meeting.

At its meeting of September 18, 2020, the Exhibition Place Board considered (Report EP13.3 Adoption attached above) a ten (10) year sign agreement with Branded Cities for two digital signs at Lakeshore Boulevard entrances to Exhibition Place which would replace the two existing static entrance signs (same size and location). The new digital signage will provide Exhibition Place with the ability to promote events and tenants as well as welcome guests on event days at no additional cost while in fact adding an increased revenue stream.

Exhibition Place and CREM staff consulted with the City staff from the Sign By-Law Unit on the compatibility of the proposed signage, and staff from the Sign By-Law Unit attended the September 18, 2020 Exhibition Place Board meeting. Sign By-law Staff advised, that although the proposed digital signage is replacing the existing static signage, any replacement would require a sign by-law amendment.

Given the current COVID-19 pandemic situation and the forecasted cost increase to host large scale events, the benefit derived from replacing the current static signage to digital is an important driver for promoting our events and supporting our tenants.

Your support in approving the proposed signage would be very much appreciated.


