PROPOSAL

The application to amend the Zoning By-law proposes to permit the construction of three towers (36, 34 and 31 storeys in height) for the property at 2075 Kennedy Road, 26 Village Green Square and 50 Village Green Square. The proposal includes a total of 920 dwelling units, 713 square metres of office space and 607 square metres of retail space at grade and a new public park is proposed to be dedicated on the southwest corner of the site. The existing 13 storey office building and associated parking structure will be retained.

This land is also subject to an application under the *Planning Act* for consent to sever lands under Application No. B0021/20SC.


FURTHER INFORMATION

Zoning By-law Amendments Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, attention: Carlie Turpin, Administrator, Scarborough Community Council, at the address or e-mail set out in this notice.

public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your
