SUMMARY

The purpose of this report is to recommend the appointment of Members of Council to the following:

- Budget Committee
- Toronto Atmospheric Fund Board of Directors
- Film, Television and Digital Media Advisory Board

- Hockey Hall of Fame Board of Directors
- National Zero Waste Council Management Board
- Ontario Good Roads Association Board of Directors
- Waterfront Revitalization Corporation (Waterfront Toronto)

RECOMMENDATIONS

5. Striking Committee consider Members' preferences and recommend to City Council the nomination of three Council Members for appointment to the Hockey Hall of Fame Board of Directors for a term of office beginning at the Annual Meeting in Spring 2022 to the Annual Meeting in Spring 2023.

6. Striking Committee consider Members' preferences and recommend to City Council the nomination of one Council Member for appointment to the National Zero Waste Council Management Board for a term starting on January 1, 2022 and until November 14, 2022, and City Council authorize the General Manager, Solid Waste Management Services, or designate to serve as alternate on the Board.

7. Striking Committee consider Members' preferences and recommend to City Council the nomination of one Council Member for appointment to the Ontario Good Roads Association Board of Directors for a term of office starting February 27, 2022 and ending November 14, 2022 and until a successor is appointed.

8. Striking Committee recommend to City Council the appointment of one Council Member to the Waterfront Revitalization Corporation, as the Mayor's designate, for a term of office from December 13, 2021 to November 14, 2022.

As a result there is a vacancy on the Toronto Atmospheric Fund Board of Directors. Film, Television and Digital Media Advisory Board

The composition of the Film, Television and Digital Media Advisory Board is three Members of Council including one as Chair, one representative of FilmOntario, one representative of the Computer Animation Studios of Ontario and 20 members of the public.

Canadian National Exhibition Association - Board Membership requires appointment to the Municipal Section

The Hockey Hall of Fame Board of Directors includes three Council Member nominees.

The National Zero Waste Council Management Board is seeking the City's Nomination

The National Zero Waste Council Management Board has asked the City to nominate a member for its Board. The Board is composed of a maximum of 21 members including one representative of Toronto. The City can also identify an alternate. The General Manager, Solid Waste Management Services or designate is prepared to serve as alternate on the Board.

The Ontario Good Roads Association is seeking the City's Nomination
