## a. Future Majority – Youth Organizing for Green Development Standards in Mississauga

The Committee recommended funding of \$92,399 over 15 months to Future Majority to mobilize youth climate activists, organize public events and other campaign elements to support the passage of a strong Green Development Standard in Mississauga.

### b. Ryerson University – Embodied Carbon Metrics and Guidance for Building Envelope Design

The Committee recommended funding of \$130,712 over 20 months to Ryerson University to develop a methodology for calculating the embodied carbon of building enclosure assemblies for Part 3 buildings and to create guidelines and reference tools to support design teams in meeting embodied carbon targets in municipal development standards.

### c. Grant requests not recommended for funding

The Committee recommended that the TAF Board not approve six funding requests with a total value of \$822,603.

### a. TCH Portfolio Decarbonization Partnership

The Committee recommended funding of \$100,000 over 6 months to TAF's Retrofit Accelerator team to support Toronto Community Housing in implementing their building portfolio decarbonization program. Funding will enable TAF to develop a deep retrofit planning tool, create an aggregated procurement strategy, and to pilot the use of artificial intelligence to optimize building performance.
