Establishing a Human Resources Committee and Its Priorities

SUMMARY

This report provides an update on human resource-related activities and recommends changes to the name and scope of the Executive Compensation and Performance Review Committee to serve the wider mission-critical HR needs of the organization.

The Committee has identified two priorities for 2022: succession planning and recruitment as TAF's VP Impact Investing is retiring in June and guidance on responding to the compensation study currently being undertaken.

RECOMMENDATIONS

The Vice President, Strategy and Partnerships recommends that the TAF Board of Directors:

- 1. Change the name of the Executive Compensation and Performance Review Committee to the Human Resources Committee.
- 2. Approve the Terms of Reference of Human Resources Committee as presented in Attachment 1.
- 3. Appoint Andrew Dooner as Chair of the Human Resources Committee.

In addition to the existing mandate which includes performance review and compensation for TAF's CEO, the Committee will provide support and guidance as needed by TAF management.

Andrew Dooner will join the Committee as Chair. Members include Parminder Sandhu and Councillor Shelley Carroll who were appointed in February 2020 for four year terms.
