The Committee Chair, Parminder Sandhu, welcomed members and staff and called the meeting to order.

4. New hires since April

Fatima Crerar provided updates on TAF's recent hires and recruitment processes currently underway.

Staff shared human resources related risks as identified in TAF's risk register.

6. Compensation strategy project kick-off

Staff provided an update on the compensation review work underway. Staff are working with an external consultant, CastleHR to complete a compensation study including job evaluation, market review, and updated salary structure design. The results of the study will inform recommendations for salary adjustments where current inequities exist. Staff have included a line for salary adjustments in the 2022 budget that will be allocated as needed. The Committee advised staff to consider all elements of TAF's Total Compensation when determining adjustments required.

Staff provided an update on plans to return to the office including changes to the office layout and equipment to support a larger, hybrid team. Internet connectivity and speed in our office building is an issue that has potential to impact productivity.
