

Extension of Permit Parking Hours - Sumach Street

SUMMARY

This staff report is about a matter that Community Council has delegated authority from City Council to make a final decision.

Transportation Services is recommending that overnight on-street permit parking hours be extended on Sumach Street, between Eastern Avenue and Adelaide Street East, from 12:01 a.m. to 10:00 a.m., 7 days a week to the new hours of 12:01 a.m. of one day to 12:01 a.m., the following day, 7 days a week.

Residents requested the extension of the overnight on-street permit parking hours on Sumach Street, to improve parking flexibility and to allow the Parking Enforcement Unit, Toronto Police Service, to effectively control long term parking by non-residents through tagging and towing operations.

RECOMMENDATIONS

The Director, Permits and Enforcement, Transportation Services recommends that:

1. Toronto and East York Community Council authorize the extension of the overnight on-street permit parking hours on Sumach Street, between Eastern Avenue and Adelaide Street East from 12:01 a.m. to 10:00 a.m., 7 days a week to the new hours of 12:01 a.m. of one day to 12:01 a.m., of the following day, 7 days a week.
2. Toronto and East York Community Council prohibit parking at all times on the east side of Sumach Street, between Eastern Avenue and a point 44.5 metres north.

FINANCIAL IMPACT

The estimated funding to extend permit parking hours is \$200 which is available within Transportation Services 2021 Interim Operating Budget.

DECISION HISTORY

This report addresses a new initiative.

COMMENTS

A request was received from the Ward Councillor, on behalf of area residents, to extend the overnight on-street permit parking hours on Sumach Street between Eastern Avenue and Adelaide Street East.

Existing Conditions

Sumach Street between Eastern Avenue and Adelaide Street East is characterized by the following conditions:

- It is a two-lane, northbound/southbound, local roadway
- It operates two-way on a pavement width of approximately 7.3 metres
- There are sidewalks located on the west side of the street only.
- There is no TTC service.

The parking regulations on Sumach Street within the subject section are as follows:

East Side

- Currently signed as no parking anytime.

West Side

- Currently signed as, overnight on-street permit parking from 12:01 a.m. to 10:00 a.m., 7 days a week
- Currently signed as maximum one-hour parking, from 10:00 a.m. to midnight., 7 days a week

A map of the area is included in Attachment 1.

Transportation Services has no objections to the extension of permit parking on Sumach Street, between Eastern Avenue and Adelaide Street East. Transportation Services has also suggested including the recommendation to prohibit parking anytime on the east side of the subject section of Sumach Street as a housekeeping item to ensure the bylaw matches the current signage.

The Ward Councillor has been advised of the recommendation in this report.
