## **PROPOSAL**

The application to amend the Zoning By-law proposes to permit a 13-storey mixed use building containing 893 square metres of retail space, 219 dwelling units, 224 bicycle parking spaces and 34 vehicle parking spaces for the property at 315-325 Spadina Avenue. As part of the 219 dwelling units, at least 22 units are proposed to be secured as affordable housing.
