## NOTICE OF PUBLIC MEETING

Request to Amend the Official Plan and Zoning By-law 569-2013 Application No. 18 223807 SPS 00 OZ

Location of Application: King-Parliament Secondary Plan Area

Lands generally bounded by Jarvis Street, Front Street East, Lower Sherbourne Street, The Esplanade, Parliament Street and the Canadian National Railway corridor, including certain lands on the north side of Queen Street East between Sherbourne Street

and River Street.

## **PROPOSAL**

The purpose of this Official Plan Amendment and Zoning By-law Amendment is to replace the existing King-Parliament Secondary Plan (Chapter 6, Section 15 of the City of Toronto Official Plan) with a new Secondary Plan, and to amend Zoning By-law 569-2013 for the King-Parliament area. The Secondary Plan builds on the Downtown Plan (OPA 406) to provide area-specific policies on the replacement of non-residential space, heritage context, built form and opportunities to improve and expand parks and the public realm. The Official Plan Amendment will also redesignate the West Don Lands area, generally bounded by Eastern Avenue, Parliament Street, Mill Street and Bayview Avenue, as *Mixed Use Areas* and *Parks*.

The Zoning By-law Amendment aligns with the Secondary Plan to update local zoning regulations and built form standards to implement policy directions within the Secondary Plan. The proposed Zoning By-law Amendment would also have the effect of incorporating significant portions of the King-Parliament Area previously excluded from City-wide Zoning By-law 569-2013, with updated zone categories and land uses consistent with existing and planned *Mixed Use Areas* land use designations in the Downtown Plan (OPA 406). The Zoning By-law Amendment also provides area-specific regulations regarding maximum permitted heights, minimum required building setbacks, streetwall heights and step-backs.

A portion of these lands is also subject to various Minister's Zoning Orders filed under the Planning Act on October 22, 2020 as O. Reg. 594/20, O. Reg. 595/20 and O. Reg. 596/20.



If you wish to be notified of the decision of the City of Toronto on the proposed Official Plan Amendment and/or passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk attention: Ellen Devlin, Administrator, Toronto and East York Community Council, at the address, fax number or e-mail set out in this notice.

Official Plan and Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Toronto City Council to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Official Plan Amendment is adopted or refused or the Zoning By-law Amendment is enacted or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so. You may submit comments to the City Clerk, attention: Ellen Devlin, Administrator, Toronto and East York Community Council, at the address, fax number or e-mail set out in this notice.

**People writing or making presentations at the public meeting:** The *City of Toronto Act*, 2006, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.

The City collects this information to enable it to make informed decisions on the relevant issue(s). If you are submitting letters, faxes, e-mails, presentations or other communications to the City, you should be aware that your name and the fact that you communicated with the City will become part of the public record and will appear on the City's website. The City will also make your communication and any personal information in it - such as your postal address, telephone number or e-mail address - available to the public, unless you expressly request the City to remove it.
