## **PROPOSAL**

The existing site-specific Zoning By-law 108-2017 and 109-2017 permit seven 3-storey detached houses and two 3-storey semi-detached houses at 350 Vaughan Road. This Zoning By-law Amendment is being considered to allow the site to be developed in two phases. The first phase includes the western three detached houses and the second phase includes the eastern six detached and semi-detached houses.



City initiated Zoning By-law Amendments: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the City initiated Zoning By-law Amendment, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so.
