### PROPOSAL

The application proposes to demolish 57 rental dwelling units in order to redevelop a portion of the lands with a mixed-use development comprised of two purpose-built rental apartment buildings, each 33 and 24 storeys in height and together containing 824 rental dwelling units, including 70 replacement rental units. Commercial office and retail uses would be located between the first and fourth floors of the buildings. The total Gross Floor Area (GFA) of the proposed development is approximately 76,300 square metres, of which approximately 60,700 square metres is residential GFA and approximately 15,600 square metres is non-residential GFA.

A Rental Housing Demolition and Conversion application (17 160339 STE 28 RH) under Section 111 of the *City of Toronto Act, 2006* (Chapter 667 of the Municipal Code) has been submitted to permit the demolition. Under the *City of Toronto Act, 2006*, the demolition of a rental property with six or more dwelling units is prohibited without obtaining a permit from the City. Decisions by City Council on the rental housing demolition application are not subject to appeal to the Local Planning Appeal Tribunal (LPAT).


