

## **Realignment of Permit Parking Area 6D- to Exclude the Development Located at 203 College Street**

### **SUMMARY**

---

As the Toronto Transit Commission (TTC) operates a transit service on College Street, City Council approval of this report is required.

The purpose of this report is to respond to Toronto and East York Community Council's direction to review and report back on the realignment of Permit Parking Area 6D to exclude the development located at 203 College Street.

Staff have determined the realignment of the Permit Parking Area 6D is feasible and has no objections to excluding the development located at 203 College Street. If City Council excludes this address from the subject Permit Parking Area, residents and visitors of this address will be prohibited from participating in the on-street permit parking program.

### **RECOMMENDATIONS**

---

The Director, Permits and Enforcement, Transportation Services recommends that:

1. Toronto City Council approve the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of Permit Parking Area "6D", as shown in Attachment 1 of the report dated August 23, 2021 from the Director, Permits and Enforcement, Transportation Services

## **DECISION HISTORY**

---

At its meeting of June 24, 2021, Toronto and East York Community Council adopted item TE26.79, and in so doing, requested Transportation Services to examine and report back regarding the realignment of Permit Parking Area 6D to exclude the development address of 203 College Street.

## **COMMENTS**

---

Transportation Services received a request from the Ward Councillor on behalf of local residents to realign Permit Parking Area 6D, to exclude the development located at 203 College Street.

Permit Parking Area 6D is bounded by the College Street to the north, McCaul Street to the east, Queen Street West to the south and Spadina Avenue to the west. Area 6D has 522 on-street parking spaces. To date, 286 permits have been issued. This area does not have a history of being waitlisted, meaning the demand for overnight on-street parking permits has never exceeded the supply of parking spaces.

A map of Permit Parking Area 6D is included in Attachment 1.

The exclusion of the development located at 203 College Street is a means to ensure that current permit holders have sufficient parking space. The issuance of parking permits to residents, guests, tradespeople and caregivers of this development would negatively impact on the already limited parking supply in the neighbourhood.

A Public Notice was placed on the City's website requesting those objecting to the exclusion of 203 College Street from permit parking in Permit Parking Area 6D forward their objections in writing to the City Clerk, so they may be scheduled as deputations at the Toronto and East York Community Council meeting.

Transportation Services has no objections to the exclusion of 203 College Street from Permit Parking Area 6D.

The Ward Councillor has been advised of the recommendation in this report

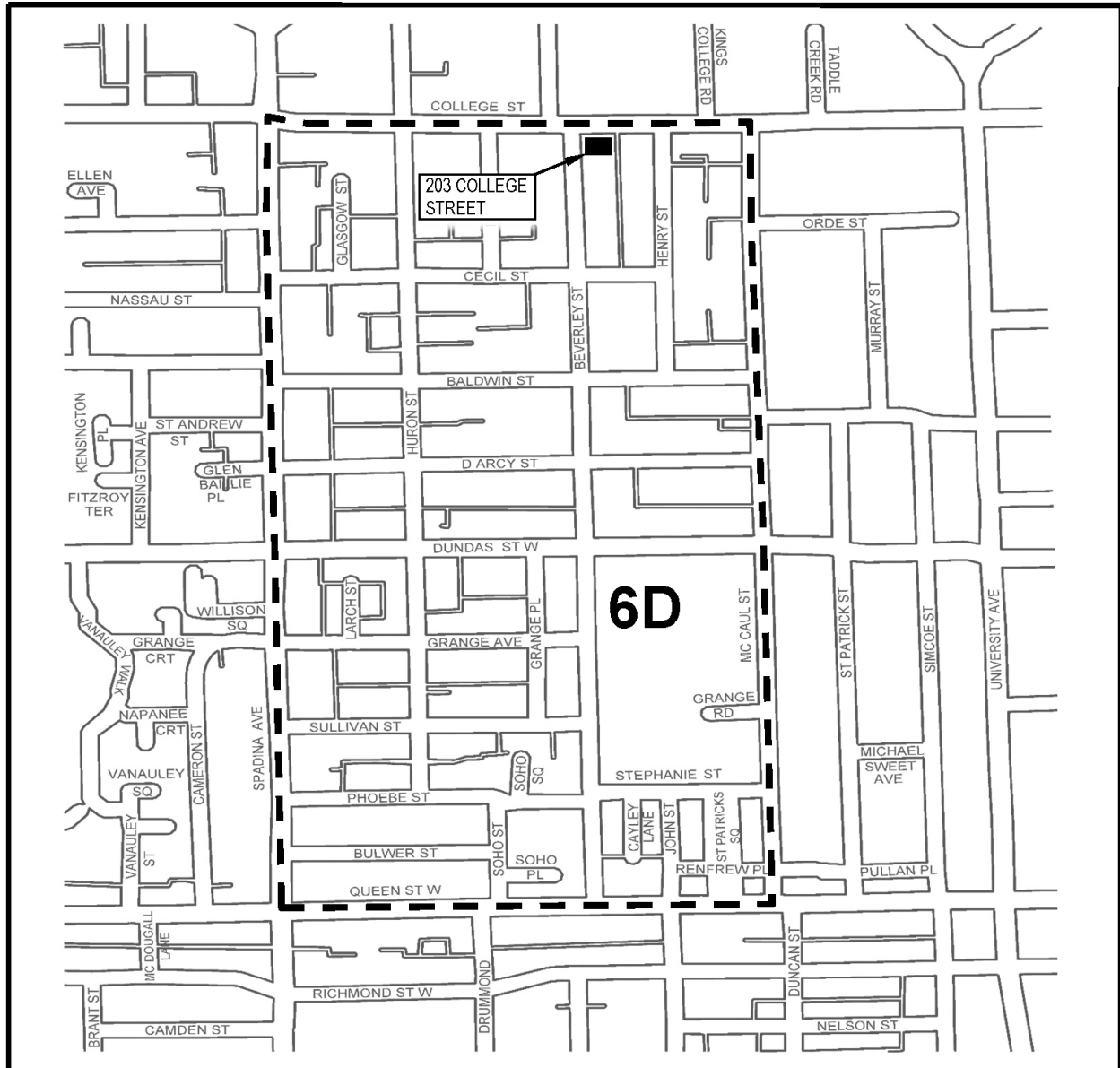
