Alterra Finer – Corktown Ltd.
18 – 32 Eastern Avenue, 1 Gilead Place and 2 Sackville Street

We are counsel to Alterra Finer – Corktown Ltd. ("Alterra"), the owner of the property municipally known in the City of Toronto as 18 – 32 Eastern Avenue, 1 Gilead Place and 2 Sackville Street (the "Property"). The Property is proposed to be subject to the draft King-Parliament Secondary Plan (the "Secondary Plan") and King-Parliament Zoning By-law Amendment (the "KP ZBA").

On May 18, 2017, Alterra appealed the site specific Official Plan Amendment ("**OPA**") and Zoning By-law Amendment ("**ZBA**") Application (Municipal File No. 16 216777 STE 28 OZ) for the Property to the Local Planning Appeal Tribunal ("**LPAT**") due to Council's non-decision. In a decision issued on August 21, 2019, the LPAT approved the OPA and ZBA in principle (LPAT Case No. PL170624), with final approval being withheld upon the satisfaction of several conditions.

Alterra submitted a site plan approval ("SPA") application for the Property and has been working cooperatively and diligently with City Staff to satisfy the LPAT's approval conditions and to finalize the OPA and ZBA so to bring the matter back before the LPAT for final approval.

There are no transition provisions in the Secondary Plan or the KP ZBA. Applying the Secondary Plan and the KP ZBA to the Property at this time is unfair given how far Alterra has progressed towards having the site specific OPA and ZBA approved.

To avoid Alterra having to appeal the Secondary Plan and the KP ZBA, we ask that the Property be exempt and excluded from the Secondary Plan and the KP ZBA.
