Re: TE27.15: Request for Fence Exemption - Front Yard 38 Helena Avenue, Toronto

We are counsel to Catherine Donaldson (the "Applicant"), the owner of the property located at 38 Helena Avenue in the City of Toronto (the "Subject Lands"). This letter has been prepared in support of an application for a site-specific fence exemption to allow for fence heights on the Subject Property to exceed the maximum permitted height of 1.2m, pursuant to Chapter 447-1.2B(1) of the Toronto Municipal Code (the "Application"). The Application is scheduled to be considered by Toronto East York Community Council on September 9, 2021.

By way background, the Applicant acquired the Subject Lands in 2018 and has spent the past few years restoring the property. The fence is located entirely on the Subject Lands and was constructed as a privacy screen to obscure the neighbour's unkept front yard, which is used as storage for various bins and littered with debris.

A Notice of Violation was issued, dated November 20, 2020, indicating that the newly installed fence exceeded the maximum allowable fence height of 1.2m (within 2.4m of a public highway). The Application was submitted on December 11, 2020 and included five letters of support from surrounding neighbours, which welcomed the improvement and enhancement to the property.

The fence was constructed in a sensitive manner, gradually decreasing in height in three separate sections. City Staff in the report dated June 20, 2021 (the "Report"), confirm that the fence does not contravene any other provisions of the by-law. The Report also provides photographic evidence that the fence does not produce a sightline violation.

The fence was constructed to ensure that there is plenty of space between the wood slats, rather than an entirely opaque design, and is consistent with the character of other fences within the neighbourhood, both in style and height.

The Applicant has undertaken a survey of fences in the surrounding neighbourhood and found that there are multiple fences of a similar, well-designed style that appear to exceed the 1.2m and 2.0m maximum fence heights established by the Toronto Municipal Code. Examples are enclosed.

Based on the foregoing, we request that Council adopt Staff Recommendation #2 in the Staff Report to grant the application for the existing front yard fence on the Subject Lands, without conditions.
