The Contract is expected to start on from the date of award and end on January 31, 2027.

FINANCIAL IMPACT

The total contract award identified in this report is \$2,712,000 including all applicable taxes and charges and \$2,400,000 net of all applicable taxes and charges. The total cost to the City is \$2,442,240 net of HST recoveries.
