#### FINANCIAL IMPACT

The total contract award identified in this report is \$1,413,372 net of all applicable taxes and charges. The cost to the City is \$1,438,247 net of HST recoveries.

The engineering estimate for this project is \$1,588,861.28 net of all applicable taxes and charges.

- e. the Fair Wage Office confirms the recommended firm understands the Fair Wage Policy and Labour Trades requirements and has agreed to comply fully.
