Contract is expected to start on date of award and end on December 31, 2025.

FINANCIAL IMPACT

The total contract award identified in this report is \$3,806,165 including all applicable taxes and charges. The cost to the City is \$3,427,569 net of HST recoveries.

The engineering estimate for this project is \$3,368,287 net of all applicable taxes and charges.

Funding is available in the 2022 Approved Capital Budget and included 2023-2031 Approved Capital Plan for Toronto Water. Funding details are summarized in Table 1 as follows:
