Contract is expected to start on date of award and end on December 31, 2024.

FINANCIAL IMPACT

The total contract award identified in this report is \$9,144,582 including all applicable taxes and charges. The cost to the City is \$8,234,979 net of HST recoveries.

The engineering estimate for this project is \$6,583,669 net of all applicable taxes and charges.

Funding is included in the 2022 Approved Capital Budget and the 2023-2031 Approved Capital Plan for Toronto Water. Funding details are summarized in Table 1 as follows.
