FINANCIAL IMPACT

The total contract award identified in this report is \$14,368,458 including all applicable taxes and charges. The cost to the City is \$12,939,241 net of HST recoveries.

The engineering estimate for this project is \$11,404,840 net of all taxes and charges.

Funding is included in the 2022 Approved Capital Budget and 2023 - 2031 Approved Capital Plan for Transportation Services. Funding details are summarized as follows:
