Description:

For the Supply and Delivery of all Labour, Materials, Equipment and Supervision required to complete the Lower Don Trail Improvements Phase 2, on behalf of the Parks, Forestry and Recreation Division of the City of Toronto.

Recommended Supplier:

Grascan Construction Ltd.

Contract Award Value:

\$10,364,920 net of all applicable taxes and charges \$11,712,360 including HST and all applicable charges \$10,547,343 net of HST Recoveries

The contract is expected to start following the date of award and end by August 31, 2023.

FINANCIAL IMPACT

The total contract award identified in this report is \$11,712,360 including all applicable taxes and charges. The cost to the City is \$10,547,343 net of HST recoveries.

The engineering estimate for this project is \$11,225,000 excluding all taxes and charges.

Funding is available in the 2022 Council Approved Capital Budget and 2023-2031 Capital Plan for Parks, Forestry and Recreation and Transportation Services, as summarized in Table 1 below.
