While the 2022 Staff Recommended Tax Supported Budget sets out the recommended fees, the appropriate Committee may change these recommendations and Toronto City Council may adopt rates that differ from the recommendations, including fees that are higher or lower than the fees being recommended, and may adopt new fees not contemplated in the staff recommended budget.
