# 2022 OPERATING BUDGET BRIEFING NOTE 2022 Environment & Energy Division Staffing, Work Plan and Reports to Council and Committees

## Issue/Background:

On January 20th, 2022, the Budget Committee requested the Executive Director, Environment & Energy to provide a briefing note on implementation of the Net Zero strategy, including:

a. Energy and Environment's Full-Time Equivalent complement for 2022, including filled and vacant positions; and

b. Energy and Environment's work plan for 2022, including reports that will be coming to Toronto Council and committees.

# **Environment & Energy Division's Complement for 2022**

The 2022 budget provides the resources for the EED to increase staffing levels by 37.6 to a full complement of 103.6 positions.

Given that staffing levels are critical to the EED's support for implementation of Toronto's Net Zero strategy, People & Equity have already been engaged and a hiring plan is in place. The EED will have a dedicated recruitment resource focused on filling vacant positions by leveraging partnerships within People & Equity to ensure strategic alignment of approaches geared toward efficient recruitment and retention of talent. Some of which may include:

- partnerships with our Diversity & Inclusion team members to thoughtfully plan initiatives to increase the recruitment and representation of equity deserving groups and people of colour within EED;
- expanded use of Qualified Candidate Listings (QCLs) to maximize reach across like roles and limit task duplication when hiring internal talent;
- strategic 'bundling' of roles to provide efficiency in filling multiple roles through one targeted job call;
- increased communication and outreach on employment opportunities within the Environment & Energy Division, including opportunities to support a critical priority for the City of Toronto through community partners and academia;

- coordinated approach to transition acting/temporary employees to permanent roles where the operation can benefit and provide immediate stability to those in precarious employment enhancing commitment and reducing possible turnover; and
- targeted professional development conversations with leaders during performance reviews to support proactive skill development for both immediate succession planning support and future talent pipeline creation.

# EED 2022 Work Plan and Reports to Council and Committees

With City Council's approval of TransformTO – Critical Steps for Net Zero by 2040 and the Net Zero Existing Buildings Strategy in 2021, the 2022 work plan for the EED will focus on implementation of those initiatives. This briefing note includes details on EED's work plan and reports to City Council and Committees. Implementation of these strategies involves multiple City divisions, agencies and corporations, as well as partnership with the provincial and federal governments, residents, and businesses. Scaling up existing programs and introducing new programs is a priority. The resources included in the EED 2022 budget will support a number of these initiatives, including:

#### Innovation & Scale

- Wastewater Energy Transfer program launching in Q1 2022 with potential for reducing 200,000 tons of greenhouse gas (GHG) emissions annually;
- First-in-class self-service roof-top solar map to provide information and resources to help residents and businesses assess the rooftop solar potential of their properties and proceed through the steps to installation;
- Provide 700+ free solar assessments per year through SolarTO; and
- Delivery of impactful first-of-a-kind projects (wastewater energy, renewable district energy, resilient EMS stations, net-zero community centres) that can be scaled by asset owners for mass GHG reductions.

## **Climate Action in Buildings**

- Scaling up Green Will Initiative (GWI) working with major institutions in the City to reduce GHG and introducing a Strategic Energy Management program for GWI participants which provides pathway to net-zero;
- Launch and operate the new version of Toronto Green Standard (version 4- May 2022);
- Enhancing the Home Energy Loan Program with funding from Federation of Canadian Municipalities (FCM) to make retrofits easier and more affordable;
- Setting requirements to assess building performance and create a pathway to net zero;
- Support for a \$200 million grant application to the Federal Government for 15 netzero new community centres; and
- Continuation of existing TransformTO initiatives.

## Outreach, Engagement & Education

- Deeper engagement on climate action with Toronto's equity-deserving communities, Indigenous communities and youth;
- Increased community outreach & education;
- Further expanding the Neighbourhood Climate Action Champions and Climate Action Fund programs; and
- Supporting employers and employees across the City with a safe and sustainable commute in the Return to the Office as part of COVID-19 recovery.

In addition to these initiatives, the EED will deliver a number of reports to Infrastructure & Environment Committee in 2022:

Toronto's Ambient Air Quality Impacts from COVID-19	Q2 2022	The report will identify air pollution sources within Toronto by studying variations of air pollutant concentrations before, during, and after the implementation of movement restrictions to reduce the spread of COVID-19. Further, the report will capture behavioral changes of Toronto residents during the study time period.
Energy Retrofit Loan for Net Zero Building	Q2 2022	Report seeks authorization for a specific project looking to participate in the Energy Retrofit Loan (ERL) program. Through ERL the City offers low- interest loans to help building owners improve the energy efficiency of their buildings. At present program applicants are required to demonstrate a positive ROI based on utility saving alone. This report will seek authorization to expand the criteria by which this project can be authorized to receive financing, while at the same time ensuring the utmost efforts are made to limit risk to the City. This project is intended to provide a foundational case- study for enabling deeper, more holistic retrofits in support of the City's TransformTO objectives. Wastewater Energy Transfer Program	Q2 2022	Seek approval for multi-stakeholder circulation process, as per Council direction in December (2021.IE26.18).
