## Tree Removal Permit Appeals – Delegation to Community Council

## Amendments to City of Toronto Municipal Code Chapter 27, Council Procedures

The Executive Committee and Toronto City Council will be considering recommendations to pass a by-law to amend City of Toronto Municipal Code Chapter 27, Council Procedures, in order to delegate to Community Councils the authority to make final decisions on Tree Removal Permit Appeals.

It is proposed that the by-law be adopted at the City Council meeting on May 11 and 12, 2022 or at a subsequent meeting.

The letter from Councillor Paul Ainslie has the following recommendation:

1. City Council delegate to Community Councils the authority to make final decisions on Tree Removal Permit Appeals, by adding "Tree permit appeals" to Chapter 27, Council Procedures, Section 18.4.C. and that Chapter 813, Trees, be amended accordingly.

If approved by City Council, City of Toronto Municipal Code Chapter 27, Council Procedures, will require amendment.

At its meeting to be held on May 4, 2022, at 9:30 a.m. or as soon as possible thereafter, the Executive Committee of Toronto City Council will hear in person by video conference, or by his or her counsel, agent or solicitor, any person who wishes to speak to the matter.
