METROLINX'S APPROACH TO INDIGENOUS ENGAGEMENT AT THE FIRST PARLIAMENT SITE AND FUTURE CORKTOWN STATION SITES

Through EX31.2¹, City Council directed staff to report back on Indigenous consultation undertaken at the First Parliament and Corktown site.

Metrolinx acknowledges that the lands over which the First Parliament buildings were erected, have been home to Indigenous Peoples since time immemorial. In particular, the area is significant for the Anishnawbeg, Haudenosaunee and Wendat Peoples. The area is covered by many important agreements, including the Fort Albany Land Deed of 1701 between the Crown and the Haudenosaunee as well as the Toronto Purchase (Treaty 13), between the Crown and the Mississaugas of the Credit First Nation. Metrolinx values and respects the rights of Indigenous Peoples and is committed to meaningful engagement with Indigenous Nations, and the many Indigenous Peoples living in and around the Greater Toronto Area.

As Metrolinx continues to work towards the completion of the Corktown Station, efforts to preserve and commemorate the First and Second Parliament buildings are underway. Metrolinx acknowledges that the history of the First Parliament site is not one simply of Canadian origin, but rather holds a longer history with the original keepers of this land. The First Parliament of Upper Canada is linked to a history of colonization and harmful practices towards Indigenous Peoples. Given the significance of this site, Metrolinx is engaging with Indigenous Nations, City of Toronto and the broader community to identify opportunities for commemoration.

In March 2021, Metrolinx established the Ontario Line's First Parliament Working Group (FPWG). The mission of the FPWG is to collaboratively develop and articulate a comprehensive plan that includes both conservation and interpretation where appropriate. It also commemorates the site's historical and cultural significance during transit construction and ensure that the development of the site is consistent with public, Indigenous, and stakeholder interests and policy legislative requirements.

Membership in this working group includes: Metrolinx, Infrastructure Ontario, City of Toronto, Ontario Heritage Trust, Ministry of Heritage, Sport, Tourism and Culture Industries (MHSTCI), the Mississaugas of the Credit First Nation (MCFN). Since then, 15 meetings have been held to date, with the latest meeting occurring on March 10, 2022. Monthly meetings are planned to occur throughout summer and fall in 2022. There is also an Archaeology Side Table that provides regular and detailed updates on archaeological works occurring at the First Parliament site to Indigenous Nations, MHSTCI, Ontario Heritage Trust, Infrastructure Ontario and the City of Toronto. This Archaeology Side Table first began in October 2021. Metrolinx values contributions by the Mississaugas of the Credit First Nation and the Six Nations of the Grand River who have attended the Archaeological Side Table meetings to date. Metrolinx continues to extend an open invitation to any other Indigenous Nations who wish to participate.

Metrolinx will continue to provide regular project updates as well as share environmental and archaeological reports for review with Indigenous Nations. Metrolinx will also continue to invite participation by Indigenous Nations in all archaeological, cultural heritage and natural environment fieldwork. Metrolinx will continue to engage with First Nations and the Métis Nation of Ontario, to ensure that opportunities are offered to understand, participate in and provide feedback to the project, with a special focus on the archaeological and interpretation and commemoration plans.
