1. Amend Toronto Municipal Code Chapter 441, Fees and Charges, Appendix C – Schedule 11 to reflect updates to appraisal fees.

2. Amend Toronto Municipal Code Chapter 442, Administration of Fees to add new section regarding appraisal of land value
