## NOTICE OF PUBLIC MEETING

To be held by the Etobicoke York Community Council (Under the Planning Act)

Request to Amend the Zoning By-law Application Number 19 252405 WET 03 OZ

## **PROPOSAL**

The application proposes to amend the Zoning By-law to permit a two-tower development with building heights of 27 and 33-storeys connected by a 4 to 6 storey base at 8-26 Jopling Avenue South. The proposed development includes 678 residential units, 459 square metres of commercial space, 467 square metres of community space, 422 vehicular parking spaces and a 257 square metre Privately Owned Publicly Accessibly Space ("POPS"). The proposed development would have a Floor Space Index of approximately 11.3 times the area of the lot. The proposed Zoning By-law amendments would be subject to holding provisions.



Zoning By-law Amendments Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to



appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, attention: Nancy Martins, Administrator, Etobicoke York Community Council, at the address, fax number or e-mail set out in this notice.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
