NOTICE OF INTENTION TO AMEND THE SITE SPECIFIC ZONING BY-LAW 814-2021, AS AMENDED (By-law 1268-2018) FOR 5365 DUNDAS STREET WEST TO REMOVE A HOLDING SYMBOL (H) FROM PHASE 3 (Under the <u>Planning Act</u>)

Application to amend the site-specific zoning by-law for 5365 Dundas Street West to remove the holding symbol from Phase 3, which restricts the addition of new buildings within Phase 3 until certain conditions are met. Removal of the holding symbol from Phase 3 would permit the development of a new 36-storey residential rental apartment building and a new 37-storey residential condominium building. 5365 Dundas Street West Ward 3 – Etobicoke-Lakeshore


FURTHER INFORMATION
