#### PROPOSAL

The application is to amend the Official Plan and Zoning By-law 1-83 and city-wide Zoning By-law 569-2013 to permit a mixed-use development including two tall buildings each with heights of with heights of 35storeys and 29-storeys connected by an 8-storey building element and with a two to three storey base for the property at 1956-1986 Weston Road, 1, 3, 3a and 5 Little Avenue. This site includes heritage properties at 1974 – 1978, 1984 – 1986 Weston Road and 3 – 5 Little Avenue that would be incorporated into the proposal. The proposal includes 739 residential units, 3,885 square metres of non-residential space, three levels of below grade parking and community space.

This land is also subject to an application under the Planning Act for approval of plan of subdivision, Application Number 21 220069 WET 05 SB.



### Official Plan and Zoning By-law

Amendments Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Official Plan Amendment and Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, attention: Nancy Martins, Administrator, Etobicoke York Community Council, at the address, fax number or e-mail set out in this notice.



**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
