Convert Pedestrian Crossover to Traffic Control Signal – Cordova Avenue and

Central Park Roadway

Toronto Lands Corporation (TLC) is a wholly owned subsidiary of the Toronto District School Board (TDSB) and its exclusive land use planning and real estate service provider.

TLC strongly supports Councillor Mark Grimes' motion for recommending City Council to authorize the installation of traffic control signals at the intersection of Cordova Avenue, Central Park Roadway and the egress point of Islington Junior Middle School.

Pedestrian safety has become a significant concern for the school community due to existing traffic volumes and unsafe turns at this intersection and the area around the school. There are many active development applications being processed by the City or are currently under construction in the vicinity of the school. Some of these sites include:

The additional vehicular traffic volumes from these developments will only exacerbate safety concerns. The existing pedestrian crossover is not sufficient in protecting the safety of pedestrians today, or in the future once the above properties are developed. TLC's traffic consultant, HDR Corporation, has reviewed the traffic operations and safety of this intersection in light of the above development, and has concluded that the proposed traffic signal is warranted and recommended under existing and future conditions. The proposed traffic signal will improve traffic operations and provide much improved, safe pedestrian crossing for students and the community.

TLC is very much appreciative of the collaborative efforts and support of the Councillor's office in ensuring the safety of students and pedestrians in this community.
