

City of Toronto Act, 2006 Public Notice
Extending the Vehicle Age Limit for Accessible Taxicabs

Toronto City Council will be considering recommendations to adopt amendments to City of Toronto Municipal Code Chapter 546, Licensing of Vehicles-for-Hire.

It is proposed that the amendments be adopted at the City Council meeting to be held on July 19-20, 2022, or at a subsequent meeting. If adopted by City Council, the amendments to City of Toronto Municipal Code Chapter 546, Licensing of Vehicles-for-Hire will:

1. City Council amend Toronto Municipal Code Chapter 546, Licensing of Vehicles-for-Hire, to permit a vehicle used as an accessible taxicab to be up to ten model years old and stipulating that this provision is in effect until December 31, 2025 and shall be repealed on January 1, 2026.

The proposed amendments are outlined in the report titled "Extending the Vehicle Age Limit for Accessible Taxicabs ".
