Harris Associates L.P. – Clyde McGregor to relinquish portfolio management responsibilities of the Global All Cap strategies effective December 2023

Recommendation

Harris Associates L.P. (“Harris”) has announced that Clyde McGregor will relinquish portfolio management responsibilities of the Global All Cap Strategies effective December 2023. Tony Coniaris, a current member of the Global All Cap strategy portfolio management team, will assume McGregor’s portfolio management responsibilities. Harris has also announced the addition of Colin Hudson and John Sitarz to the Global All Cap strategy portfolio management team, as co-portfolio managers. McGregor will remain at Harris as a leader and portfolio manager in the Private Wealth Management Group.

This shift in responsibilities has been signposted by Harris for some time and this announcement provides a sufficiently long transition period. Further, we note that Coniaris is a portfolio manager for the Global Equity Strategy, managed to the same investment philosophy with larger cap focus relative to the Global All Cap offering.
