## **PROPOSAL**

The application to amend the Zoning By-law proposes to permit six townhouse units fronting onto Bayview Avenue for the property at 196 Valley Road. The townhouse units are arranged in a single block and proposed to be three-storeys and 11 metres in height. Vehicular access to the development is proposed from Valley Road via a 6.0 metre wide private driveway. There are 12 resident parking spaces within garages and one surface visitor parking space proposed.
