SUMMARY

City Council has authorized the City Clerk to shortlist, interview and recommend candidates to Community Councils for appointment to the Leaside Memorial Community Gardens Arena Board. This report recommends three candidates for appointment to the board.

COMMENTS

Composition of the Leaside Memorial Community Gardens Arena Board

The board is composed of:

- The Councillor for Ward 15
- 9 public members
- 1 representative from Infrastructure Ontario to serve for the duration of the loan from Infrastructure Ontario to the City
- 1 non-voting staff member from the Parks, Forestry and Recreation Division

There are currently three positions under consideration

These positions are a result of the resignations of Jennifer Smith on February 3, 2022, Jennifer Purves who resigned on March 20, 2022, and Chris Forbell who resigned on June 3, 2022.

Term of office

The term of office for public appointees to the Leaside Memorial Community Gardens Arena Board is four years. Members appointed will serve a term of office ending June 29, 2026, and until successors are appointed.

The City Clerk recruits and recommends candidates for Arena Boards to Community Council

City Council has authorized the City Clerk to screen, interview and recommend candidates for the Leaside Memorial Community Gardens Arena Board to the North York Community Council.

City Clerk's staff conducted outreach to attract qualified individuals with relevant skills and qualifications. City Clerk's staff promoted the opportunity using social media and volunteer search websites. Staff also invited individuals with the required qualifications and eligibility to consider applying. Consideration was also given to reflecting gender, diversity, and geographical representation on the Leaside Memorial Community Gardens Arena Board.

Staff from the City Clerk's Office and Parks, Forestry and Recreation shortlisted and interviewed 6 candidates based on the City Council approved qualifications and eligibility criteria. Parks, Forestry and Recreation staff were asked to participate on the panel as subject matter experts due to their relationship with Leaside Memorial Community Gardens Arena Board.

The panel consisted of:

- Operation Supports Officer, Community Recreation, Parks, Forestry & Recreation
- Acting People Services Consultant, Public Appointments, City Clerk's Office

The panel determined the candidates by weighing their applications and interview performance.

Staff are recommending three highly qualified candidates for appointment

Staff from Parks, Forestry and Recreation and City Clerk's Office are recommending three highly qualified candidates for appointment to Leaside Memorial Community Gardens Arena Board (see Attachment 1). These candidates cover the range of City Council approved qualifications for the Leaside Memorial Community Gardens Arena Board with the relevant knowledge and experiences.
