PROPOSAL

This application proposes to amend the Zoning By-law to permit a 13 storey rental apartment building addition beside an existing 8 storey rental apartment building at 515 and 525 Chaplin Crescent. A total of 278 dwelling units, 219 parking spaces, and a density of 3.57 times the lot area are proposed. Vehicular access is proposed via Chaplin Crescent.



Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so.
