This application proposes to amend the Zoning By-law to permit a 13-storey rental apartment building with 313 residential units and 167 parking spaces in one level underground, and a density of 3.66 times the lot area. Vehicular access is proposed via Keele Street.



Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so.
