PROPOSAL

The application to amend the Zoning By-law proposes the construction of a 19-storey residential building with a 3-storey base. The building would contain 106 affordable dwelling units with indoor and outdoor amenity space. A 3-level underground parking garage would provide 37 vehicular parking spaces and 50 bicycle parking spaces for the property at 155 and 165 Elm Ridge Drive.


If you wish to be notified of the decision of the City of Toronto on the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk attention: Julie Amoroso, North York Community Council, at the address, fax number or e-mail set out in this notice.

Zoning By-law Amendments Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the

Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, attention: Julie Amoroso, North York Community Council, at the address, fax number or e-mail set out in this notice.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
