PROPOSAL

This application proposes to amend the Zoning By-law to permit 17, 4-storey townhouse units in two blocks with an average building height of 11.36 metres. The proposed total gross floor area is 3,967.46 square metres resulting in a Floor Space Index (FSI) of 1.49 at 3358 - 3364 Bayview Avenue. The proposed 33 parking spaces will be provided in tandem within the rear, integral garage accessible by a two-way driveway accessed from Glenelia Avenue and Ruth Avenue.

entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Appeal Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so.
