PROPOSAL

The application to amend the Zoning By-law proposes to permit a commercial centre comprising of 4 new buildings 1 and 2 storeys in height and ranging in size from 616 square metres to 17,870 square metres with a total gross floor area of 19,995 square metres, as well as imposing a Holding Provision to limit any new development until such time as the engineering matters have been finalized. The Draft Plan of Subdivision application proposes to extend Vaughan Street and Parkhurst Boulevard to connect to Wicksteed Avenue, for the property at 70-80 Wicksteed Avenue, 202-206 Parkhurst Boulevard and 99 Vanderhoof Avenue.

Zoning By-law Amendments, and Draft Plan of Subdivision Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused and Plan of Subdivision is approved or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so.
