- 2. Amend Toronto Municipal Code Chapter 442, Administration of Fees to remove Legal Services' surcharges and update City Clerks surcharges levied on all fees payable under Appendix C, Schedule 13 of Chapter 441, Fees and Charges, of the Municipal Code.
