PH30.5 - Our Plan Toronto: Employment Area Conversion Requests - Preliminary Re: **Assessments Group 1** Conversion Request No. 98 (1265-1289 Lawrence Avenue West)

Dear Chair and Committee Members,

The City's Municipal Comprehensive Review ("MCR") includes the consideration of requests to convert land designated as Core Employment Areas and General Employment Areas. Approximately 140 employment conversion requests have been submitted to the City Planning Division by landowners that are seeking to introduce uses not permitted in *Employment Areas*.

Conversion Request No. 98 is for 1265-1289 Lawrence Avenue West, which is designated General Employment Areas in the Official Plan. The immediate context of this site is:

- Directly west of the site at the southeast corner of Keele Street and Lawrence Avenue West • is the North Park Shopping Centre, lands designated Mixed Use Areas.
- East of the site is the St. Joseph Communications ("SJC") site at 1235-1255 Lawrence • Avenue West and 3-15 Benton Road. The SJC site is subject to an appeal to Official Plan Amendment No. 231 ("OPA 231") before the Ontario Land Tribunal and designated Core Employment Areas and General Employment Areas by OPA 231.
- Directly south of the site are four properties on the west side of Benton Road at 10-22 • Benton Road, lands designated Core Employment Areas.

The recommendation below seeks to request that City Planning staff undertake their preliminary assessment of Conversion Request No. 98 by expanding the analysis to also include the Employment Area to the east and south of 1265-1289 Lawrence Avenue West.
