BY-LAW -2022

To amend former City of Scarborough Employment Districts By-law No. 24982 (Progress East, Marshalling Yard, and Malvern Employment Districts), as amended, respecting lands containing buildings or structures for use as public transit uses

WHEREAS authority is given to Council by Section 34 of the Planning Act, R.S.O. 1990, c. P.13, as amended, to pass this By-law; and

WHEREAS Council of the City of Toronto has provided adequate information to the public and has held at least one public meeting in accordance with the Planning Act;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. **SCHEDULE "A" EXCEPTIONS MAP** of the former City of Scarborough Employment Districts Zoning By-law No. 24982 Progress East, as amended, is further amended by deleting the current zoning and replacing it with the following Schedule '1' so that the amended zoning shall read as follows:

CCO-779-832-913-1206-1846

2. **SCHEDULE "C", EXCEPTIONS LIST**, as amended, is further amended by deleting Exception No. 849 and replacing it as following:

849. On those lands identified as Exception 849 on Schedule 'A' attached, the following provisions shall apply:

- (a) Additional permitted use: associated accessory buildings including temporary construction office
- (b) Nothing in this by-law will prevent the use of any land within the defined area for a public transit use.

3. **SCHEDULE "C" EXCEPTIONS MAP** of the former City of Scarborough Employment Districts Zoning By-law No. 24982 Marshalling Yard, as amended, is further amended by adding Exception 849 as shown on Schedule '2' on those lands known municipally as 1871 and 1901 McCowan Road and 4700 Sheppard Avenue East.

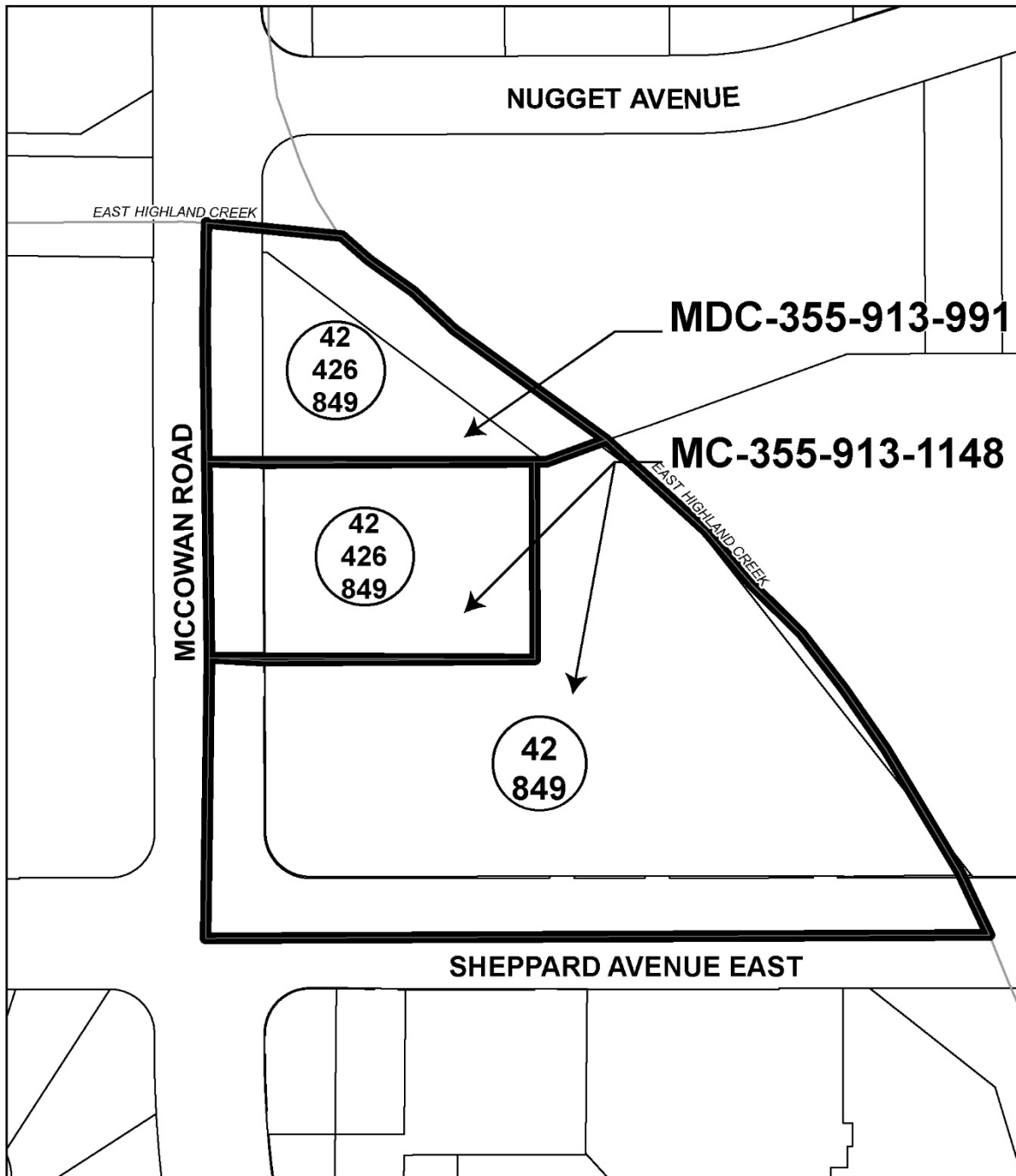

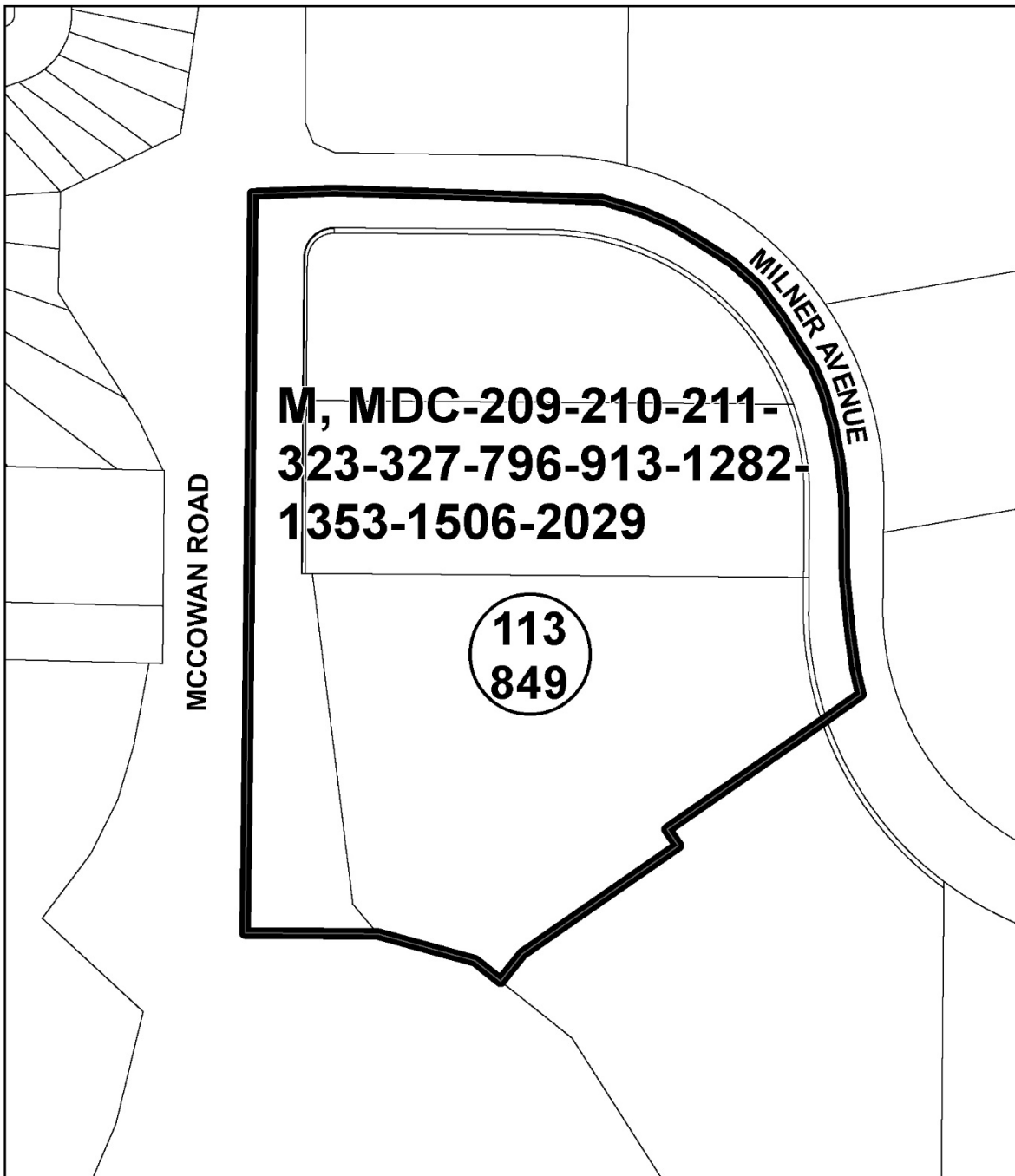

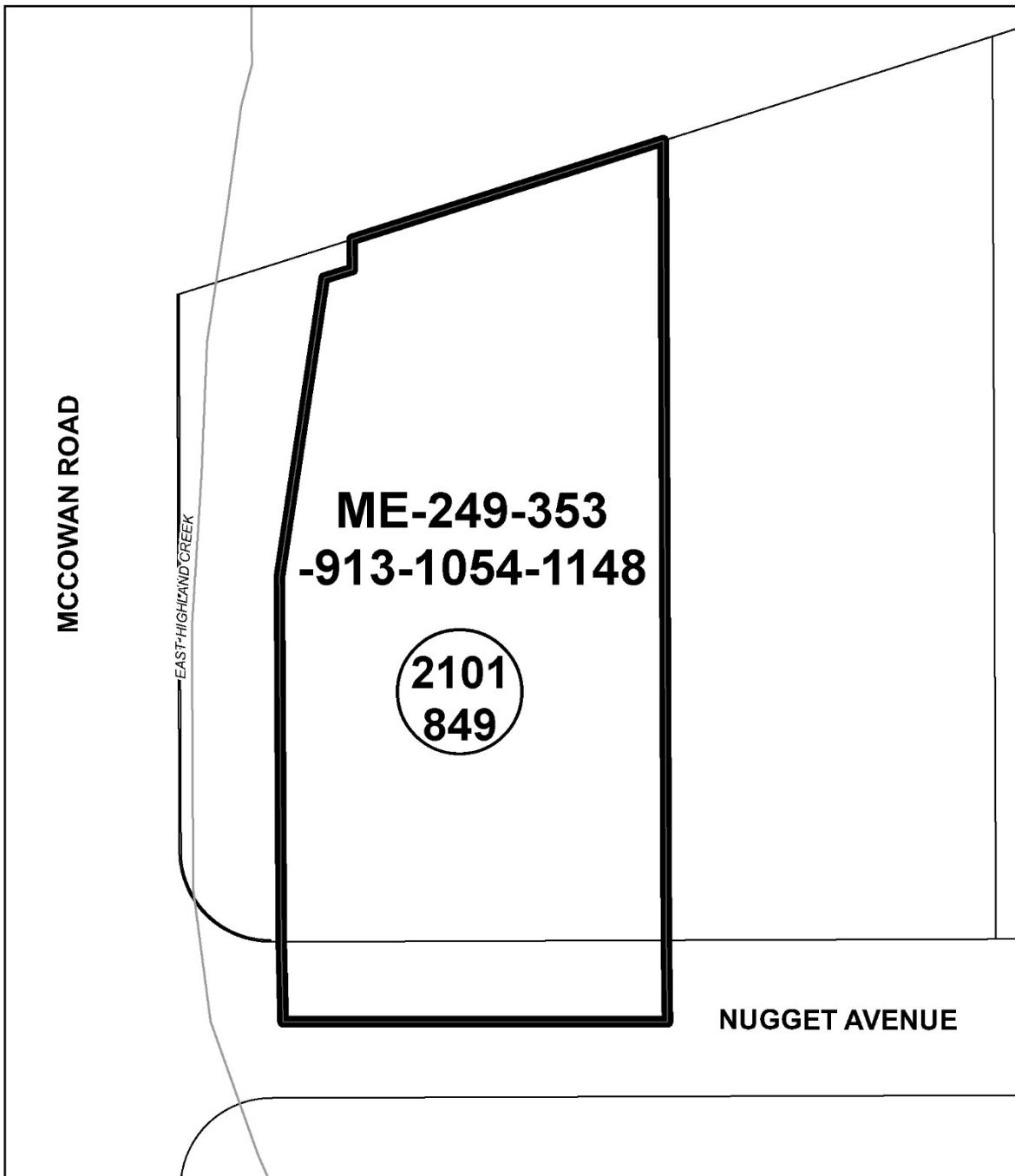
