

Application for Fence Exemption – 16 Courton Drive

To: Scarborough Community Council

SUMMARY

This staff report concerns a matter for which the Scarborough Community Council has delegated authority from City Council to make a final decision.

The purpose of this report is to consider an application by the owner(s) of 16 Courton Drive to maintain a wooden fence in the rear yard on the west side of the property which is 2.08 meters (6.8 feet) high. The maximum allowable height is 2.0 meters as specified in the Toronto Municipal Code, Chapter 447-1.2B(1) Table 1 Maximum Height of Fence – Item 9 Any of Fence 2.0 Meters. A Notice of Violation was issued on November 14, 2021.

RECOMMENDATIONS

Municipal Licensing & Standards recommends that the Scarborough Community Council:

Refuse to grant the application for an exemption permit, by the owner(s) of 16 Courton Drive, to allow them to maintain the wooden fence that is 2.08 meters (6.8 feet) high, which does not comply with the Toronto Municipal Code, Chapter 447, Fences, specifically section 447-1.2B(1) Table 1 Maximum Height of Fence – Item 9 Any of Fence 2.0 Meters.

OR

2. Grant the application for an exemption permit, by the owner(s) of 16 Courton Drive, to allow them to maintain the wooden fence that is 2.08 meters (6.8 feet) high. Direct and require that the existing fence be maintained in good repair without alteration. Direct and require that at such time as a replacement of the fence is required that such installation will comply with Municipal Code Chapter 447, or its successor by-law.

FINANCIAL IMPACT

There is no financial impact anticipated in this report.

DECISION HISTORY

As required by Section 447-1.5(B)(1), Municipal Licensing & Standards has responded to the fence exemption application by preparing this report for Scarborough Community Council's consideration, and, the City Clerk has sent all requisite notifications of the date that Scarborough Community Council will consider the application.

COMMENTS

The proposed fence violates Toronto Municipal Code, Chapter 447 – Fences requirements with respect to fence height.

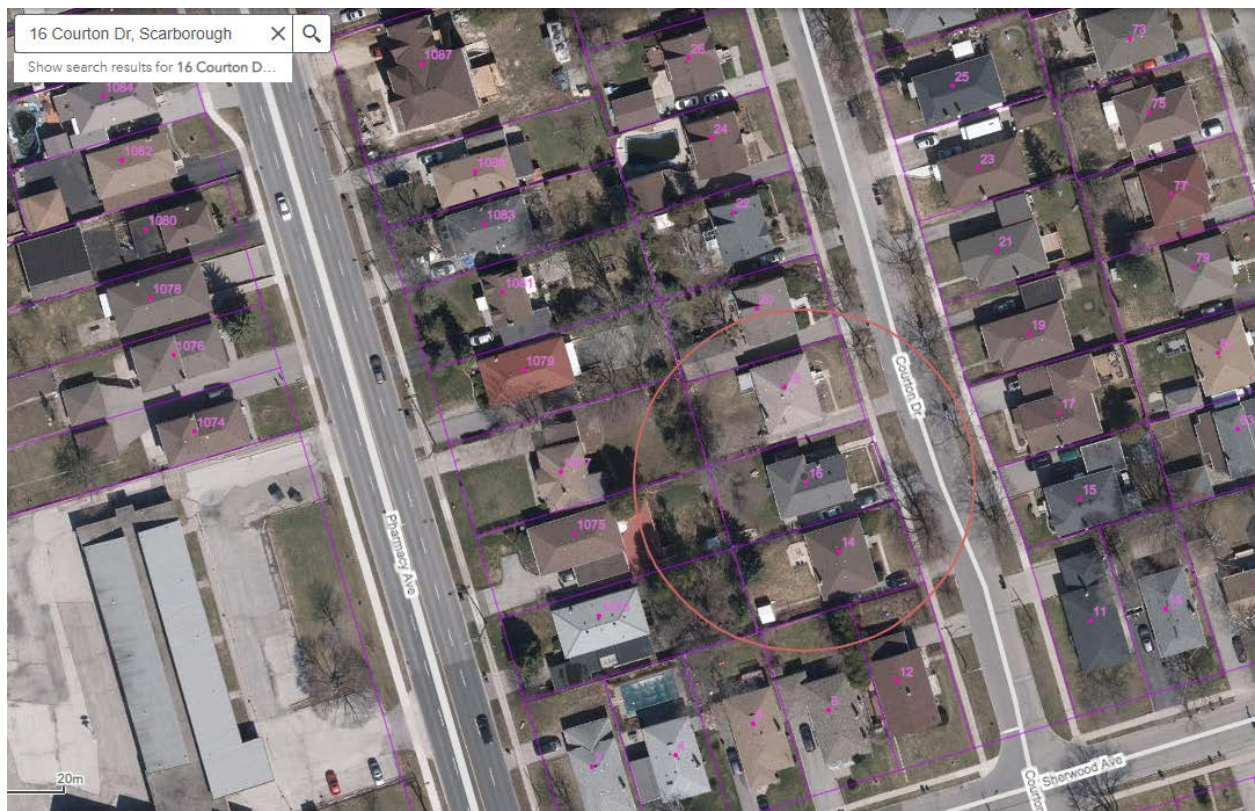
