PROPOSAL

This application (21 125114 ESC 25 OZ) proposes to amend the former City of Scarborough Highland Creek Community Zoning By-law 10827 for the property at 40 Pan Am Drive to permit the development and construction of a five-storey (22.77 m) mass timber parking structure containing a total 1,073 vehicle parking spaces. A concurrent application (21 125111 ESC 25 OZ) has been submitted to lift the Holding (H) provisions that apply to the subject site to permit the construction of the garage. The total gross floor area of the proposed building is 2,359 square metres and includes 276 square metres of ancillary office space and 773 square metres of retail uses located at grade.

The land is also subject to an Official Plan Amendment application (Application Number 16 209876 ESC 44) to adopt a Secondary Plan for the University of Toronto Scarborough Campus.


