## PROPOSAL

This application proposes to amend the City of Toronto City-wide Zoning By-law 569-2013 for the property at 4415, 4417, 4419 and 4421 Sheppard Avenue East to permit the construction of an 11-storey (35.95 metres), mixed-use development building.

The proposed mid-rise building would contain 239 residential units and a total gross floor area of 17,991 square metres resulting in an overall density of 5.2. A 325 square metre commercial-retail unit is proposed on the ground level and a 142 square metre Privately Owned Publicly Accessible Open Space (POPS) is proposed at the northeast corner of the site fronting Brimley Road. 182 vehicle parking spaces are proposed distributed through two and a half levels of underground parking. 189 bicycle parking spaces are also proposed.

The land is also subject to an application for Site Plan Approval Application Number 21 240284 ESC 23 SA.


