Request to Amend the Zoning By-law Application Number 20 164697 STE 22 OZ Draft Plan of Subdivision Application Number 20 164705 ECS 22 SB

## **PROPOSAL**

The Draft Plan of Subdivision application proposes to divide the site into two blocks, with a new public street.

The site currently contains 9 rental buildings. The applications propose to demolish seven 2-storey apartment blocks, retain the two 9-storey apartment buildings and construct three new apartment buildings ranging in heights of 8, 17 and 22 storeys along with two new blocks of stacked back-to-back townhouses. The proposal would result in 604 additional purpose-built rental units and 374 retained units. The proposed total gross floor area is 40,414 square metres which represents a density of 2.15 times the lot area. The proposal also includes a new public road with an 18.5 metre right-of-way.



If you wish to be notified of the decision of the City of Toronto on the passing or refusal of the proposed

Zoning By-law Amendment and/or decision of the City of Toronto in respect to the proposed Draft Plan of Subdivision, you must make a written request to the City Clerk, Attention: Julie Amoroso, Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice.

Zoning By-law Amendments and Draft Plan of Subdivision Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, or the Plan of Subdivision is approved or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless,



in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, attention: Julie Amoroso, Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice.

**People writing or making presentations at the public meeting:** The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
