Subject: Request to Reopen Item TE27.38 - Parking Machines - Various Streets
Intersecting Bloor Street West

SUMMARY

A staff report was presented and adopted at the September 9, 2021 T&EYCC entitled Parking Machines - Various Streets Intersecting Bloor Street West [TE27.38](#).

Subsequent to the above presentation and approval, a technical error has been discovered (see attachment 2 and 3 of the report) and requires correction.
Please read below the Background and Recommendations.

BACKGROUND:

Item TE27.38 entitled "Parking Machines - Various Streets Intersecting Bloor Street West" was adopted by Toronto and East York Community Council at its meeting on September 9, 2021. A technical error in Attachment 2 and 3 has since been discovered and will require correction. As such, a reopening and amendment of the Item TE27.38 is required.

RECOMMENDATIONS:

1. Toronto and East York Community Council reopen Item TE27.38 by amending Attachment 2 and 3 in regards to the permit parking entries for Pacific Avenue.
2. Toronto and East York Community Council amend Attachment 2: Parking Regulations to be Rescinded by:

a) Deleting the permit parking regulation in effect from 12:01 a.m. to 7:00 a.m. daily on the even side of Pacific Avenue at all times, except no parking 1st day of each month from Apr.1 to Nov. 30, inclusive; no parking anytime from a point 22.5 metres south of Oakmount Road to a point 5.5 metres further south; and no parking anytime from a point 28 metres south of Oakmount Road to a point 5.5 metres further south, from Bloor Street West to Annette Street.

b) Adding an entry for permit parking in effect from 12:01 a.m. to 7:00 a.m. daily on the even side of Pacific Avenue at all times, except no parking 1st day to the

15th day of each month from Apr.1 to Nov. 30, inclusive; no parking anytime from a point 22.5 metres south of Oakmount Road to a point 5.5 metres further south; and no parking anytime from a point 28 metres south of Oakmount Road to a point 5.5 metres further south, from Bloor Street West to Annette Street.

3. Toronto and East York Community Council amend Attachment 3: Parking Regulations to be Enacted by:

a) Deleting the permit parking regulation in effect from 12:01 a.m. to 7:00 a.m. daily on the even side of Pacific Avenue at all times, except no parking 1st day of the 15th day of each month from Apr. 1 to Nov. 30, inclusive; from Glenlake Avenue to Annette Street.

b) Adding an entry for permit parking in effect from 12:01 a.m. to 7:00 a.m. daily on the even side of Pacific Avenue at all times, except no parking 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive; from Glenlake Avenue to Annette Street.
