# **Construction Staging Area - Time Extension - Port** Lands Flood Protection - Cherry Street Temporary Diversion Road

### SUMMARY

As the Toronto Transit Commission (TTC) operates a transit service on Cherry Street, City Council approval of this report is required.

As part of the Port Lands Flood Protection Project and Enabling Infrastructure Project, Waterfront Toronto has undertaken the construction of the Cherry Street re-alignment, between Lake Shore Boulevard East and Polson Street. A construction staging area has been set-up on the west side of Cherry Street and the north side of Polson Street. In addition, a temporary detour (diversion) roadway has been fully constructed within the existing northbound lanes, east boulevard on Cherry Street, and within the additional lands on the east side of Cherry Street (leased from City of Toronto Economic Development Corporation) to accommodate northbound and southbound traffic around the construction staging area.

City Council, at its meeting on May 28, 2020, authorized the subject construction staging area on Cherry Street, from June 29, 2020 to February 28, 2022. At the time, Waterfront Toronto indicated they would require the construction staging area for a total of 34 months. At its meetings on February 2, 2022, City Council subsequently authorized extending the duration of the construction staging area until May 31, 2022.

Waterfront Toronto has requested an extension of the duration of the construction staging area on Cherry Street, in order to complete the construction of the Cherry Street re-alignment. Based on the information provided by Waterfront Toronto, the site has experienced additional construction delays due to dewatering challenges.

Transportation Services is requesting authorization to extend the duration of the construction staging area and temporary detour (diversion) roadway until July 31, 2022 in order to complete the construction of the re-alignment.

## RECOMMENDATIONS

The Director, Traffic Management, Transportation Services recommends that:

1. City Council authorize the continuation of the temporary closure to vehicular and pedestrian traffic on the west sidewalk and two southbound lanes on Cherry Street between a point 55 metres south of Commissioners Street and a point 393.5 metres further south, from June 1, 2022 to July 31, 2022, inclusive, for purposes of the Port Lands Flood Protection Project and Enabling Infrastructure Project.

2. City Council authorize the continuation of the temporary closure to pedestrian traffic on the east sidewalk on Cherry Street, between a point 195 metres south of Commissioners Street and a point 263 metres further south, from June 1, 2022 to July 31, 2022, inclusive, for purposes of the Port Lands Flood Protection Project and Enabling Infrastructure Project.

3. City Council authorize the continuation of the temporary closure to pedestrian and cycling traffic Martin Goodman Trail on the east side of Cherry Street, between a point 195 metres south of Commissioners Street and a point 263 metres further south, from June 1, 2022 to July 31, 2022, inclusive, for purposes of the Port Lands Flood Protection Project and Enabling Infrastructure Project.

4. City Council authorize the continuation of the temporary closure to vehicular and pedestrian traffic each of the north boulevard and the 5.5 metre wide portion of the westbound lane on Polson Street, between Cherry Street and a point 83.5 metres west, from June 1, 2022 to July 31, 2022, inclusive, for purposes of the Port Lands Flood Protection Project and Enabling Infrastructure Project.

5. City Council direct that Waterfront Toronto continue to be responsible for all costs incurred with respect to road repairs and traffic signage modifications.

# **FINANCIAL IMPACT**

The funding required for road operations and maintenance on the detour (diversion) roadway will be accommodated within the 2022 Operating Budget for Transportation Services.

Waterfront Toronto will continue to provide funding for all other costs including those related to road repairs and modifications to the traffic signage.

#### **DECISION HISTORY**

City Council, at its meeting on February 2, 2022 adopted Item TE30. 18 "Port Lands Flood Protection - Cherry Street Temporary Diversion Road Time Extension" to extend the closure of the two southbound lanes on Cherry Street, between a point 55 metres south of Commissioners Street and a point 393.5 metres further south, until May 31, 2022.

# COMMENTS

# **Project Status**

The Port Lands Flood Protection Project, led by Waterfront Toronto, will provide flood protection to the level of a regulatory storm event (the equivalent of Hurricane Hazel) for the Port Lands and south of Eastern Avenue areas. As part of the project, Cherry Street will be re-aligned west of its current location from Lake Shore Boulevard East to Polson Street. The re-aligned Cherry Street will be the main north-south access route for the western portion of the Port Lands.

The following is an updated summary of progress and construction activities to be completed prior to the opening of new Cherry Street and the subsequent closure of the temporary detour (diversion) roadway on Cherry Street at Polson Street on July 31, 2022:

• Delivery of Cherry Street South Bridge superstructure: Completed;

- Earthworks for the approaches to Cherry South bridge: Completed ;
- Installation of the bridge, concrete deck and bridge finishes: March 2022 to June 2022;
- Utility construction on new Cherry Street: December 2021 to July 2022;
- Utility construction on Commissioners Street, between new Cherry Street and Munition Street: to be completed by July 2022;
- Gas line installation on new Cherry Street to Polson Street: to be completed by July 2022; and
- Roadworks on new Cherry Street from Commissioners Street to existing Cherry Street and Polson Street: May 2022 to July 2022.

#### **Construction Staging Area and Diversion Road**

Construction staging operations have been set-up within the two southbound lanes on Cherry Street, between a point 55 metres south of Commissioners Street and a point 393.5 metres further south. The remaining northbound lanes and east sidewalk and boulevard on Cherry Street have been repurposed to accommodate a temporary diversion roadway and multi-use trail. With the closure in place, the Cherry Street diversion road operates as a 3.5 metre wide two-way highway in the northbound and southbound direction.

A portion of the temporary detour (diversion) road is built on lands leased from TEDCO, specifically a 5.8 metre wide portion of the east lands on Cherry Street, between a point 207.5 metres south of Commissioners Street and a point 183.7 metres further south. The subject lands is dedicated as a public highway, as per the executed lease between the City and TEDCO.

All road operations and maintenance of the temporary detour (diversion) roadway will continue to be undertaken by the City of Toronto. Transportation Services is responsible for funding the road operations and maintenance costs, while, Waterfront Toronto is responsible for all other costs including those related to road repairs. Temporary traffic control signals at the intersection of Cherry Street and Polson Street have replaced the Pedestrian Crossover (PXO).

Pedestrian movements on the west side of Cherry Street is currently restricted. The appropriate advanced warning signage has been installed at strategic locations to clearly inform pedestrians to use the east sidewalk on Cherry Street. On the east side of Cherry Street, the Martin Goodman Trail has been re-aligned in parallel with the temporary detour (diversion) road to accommodate a 1.5 metre pedestrian walkway and a 1.5 metre bike lane.

Construction staging operations on Polson Street have been set up on the north side of the roadway, within the boulevard and westbound lane. With the construction staging area in place, Polson Street in the vicinity of the site operates as a 3.5 metre wide twoway highway in the eastbound and westbound direction. Pedestrian operations on the south sidewalk remain unchanged.

#### Time Extension

Based on the information provided by Waterfront Toronto, the project has experienced additional construction delays since the authorization of the time extension on February 2, 2022. The reasons for the delay are as follows:

- Poor groundwater quality and higher than anticipated groundwater inflows resulting in delays to the groundwater drawdown;
- Dewatering challenges delayed the start and extended the duration of the utility construction on both Cherry Street and Commissioners Street;
- Inability to complete the utility construction delayed the start of the roadworks including the reconstruction of the temporary detour (diversion) road.

In view of the above, a time extension of the existing construction staging area on Cherry Street is being requested from June 1, 2022 to July 31, 2022. This will correspond with the partial opening of new Cherry Street and new Commissioners Street.

Overall, the existing construction staging area is operating acceptably, and Transportations Services does not recommend any modifications to the area for the duration of the extension. The Ward Councillor has been advised of the recommendations of this report.
